WE HAVE DISBURSED OVER \$700,000 IN TOTAL FUNDS TO MORE THAN 20 IN-COUNTRY PARTNERS. THIRTEEN OF OUR PARTNERS IN EIGHT COUNTRIES HAVE MADE SIGNIFICANT POLICY AND FUNDING ACHIEVEMENTS IN ADVANCING FAMILY PLANNING AND REPRODUCTIVE HEALTH (FP/RH) AT THE NATIONAL LEVEL AS A RESULT OF PAI'S SUPPORT. THIS IMPACT AT THE COUNTRY LEVEL IS ACHIEVED THROUGH SEVERAL OF OUR PROGRAMMATIC INITIATIVES, DESCRIBED BELOW:
