1 SIMPLY SIGN YOUR NAME: GIFTS BY BENEFICIARY DESIGNATION

Many people choose to leave a gift to PAI by naming us as a beneficiary of any of these types of accounts:

- Retirement Accounts
- Life Insurance Policies
- Bank or Brokerage Accounts
- Certificates of Deposit
- Donor Advised Funds

It's easy to do.

- 1 Check your account statement for the phone number and website of your account administrator.
- 2 Request or download a beneficiary designation form.
- 3 Designate PAI as a partial, contingent, or sole beneficiary of your account.
- 4 Sign and return the form to your plan administrator, and keep a copy for your files.

Save on Taxes with Gifts from a Retirement Account

Leaving a gift to PAI through your retirement plan account (such as an IRA) is one of the most tax-smart gifts you can make. Because most retirement plans are taxed differently than other funds, they may actually become a tax liability if left to loved ones. Because PAI is tax-exempt, we receive 100 percent of your gift to create your enduring legacy.
